Instructions, directions, and guidance related to the availability of the CARES Act Grant funds provided to students by the financial aid department at Educators of Beauty is shown below.

We are happy to share with you that Educators of Beauty will be distributing CARES Act, Higher Education Emergency Relief Fund (HEERF) grants to eligible students that have incurred expenses related to the disruption of campus operation due to COVID19

In late March 2020, President Trump signed the CARES Act (Coronavirus Aid, Relief, and Economic Security Act). This Act created an education stimulus package that included a Higher Education Emergency Relief Fund (HEERF) which contained over \$6 billion for postsecondary education emergency grants to students who experienced a disruption of their education as a result of the Coronavirus outbreak.

These emergency grant funds are intended to be used for “*expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student’s cost of attendance. Specifically*

1. **food,**
2. **housing,**
3. **course materials,**
4. **technology,**
5. **health care**
6. **and childcare**

This is not a loan. These are grant funds provided by the federal government and do not have to be repaid. It is hoped that these funds will assist you with your educational expenses to minimize any further disruption of your educational goals.

To be eligible for the assistance you must

1. be eligible to receive federal student financial assistance, (Completed a FAFSA)
2. Not be exclusively enrolled in an online program at the time of the declaration of the Coronavirus national emergency (3/13/2020)
